Objective and rationale, including the nature of urgent problems where applicable: Food Safety and Standards Authority of India issues an order for requirement of Registration of foreign food manufacturing facilities as per the list provided by Competent Authority of the exporting country for the products mentioned in order, to ensure the safety and quality of imported food products into India
